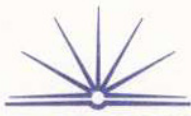

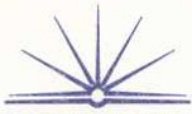

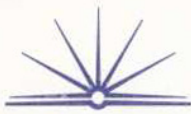
The aged need a sense of identity to

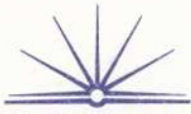
